## TESTIMONY OF TODD J. COCHRAN PARENT AND PTSO VICE PRESIDENT, CAPITOL HILL MONTESSORI AT LOGAN vicepresident@capitolhillmonttessori.org & cochran.todd@gmail.com April 14, 2016

My name is Todd Cochran, and I am a parent of two first-graders and a PK3 child at Capitol Hill Montessori at Logan. In addition, I am the vice president of our PTSO and a Ward 6 resident. Thank you for the opportunity to testify before the Committee today.

Other parents from my school testifying today are going to talk about the unfortunate and incorrect decision by the Mayor to completely omit our school from the CIP, despite our school originally being slated for a modernization in 2014 to remedy a host of dangerous, uncomfortable, and decrepit conditions impacting our children, staff, and community. But, I'm here to talk about something a bit more targeted — my three year old son's water bottle.

He takes his little pirate water bottle to school every day. He loves it. The problem is we found out last week that the water he has been drinking every school day was tested in August 2015 and found to contain an illegal level of lead. But DGS did not tell us it discovered an unacceptable level of lead in the water for seven months, so who knows how long my son had been drinking this water? And DGS has not provided data to show the issue has been remediated.

In August 2015, DGS tested 18 (out of our approximately 50) water sources at our school, and 5 came back above the federal limit for lead. In fact, one water fountain -- right by my child's classroom where he filled his little pirate water bottle every day -- was more than 20 times the federal limit. Those seven months passed with no notification to our community. Once we discovered the results and contacted the Department of Energy and Environment, those results disappeared from the website within two hours and were replaced by test results from March 2016. The new results showed that all of our tested water sources passed.

Great, right? No. The new data was faulty and unclear. Only 4 water sources from August 2015 were tested in March 2016, AND none of the 5 unsafe sources from August were re-tested. You know, including the one where my three-year old fills his little pirate water bottle.

I have attached to my testimony the provided data. Neither I nor anyone else from our school community can be absolutely certain it is safe for anybody in our school to drink. I have told my children to not drink from the water fountains until I tell them it is ok, and in fact, we disabled the fountains because we cannot be sure they are safe. Our parents and PTSO have been bringing in bottled water in the meantime, and a local Giant has donated bottled water to our school as well.

And let's not forget that not all potable water sources in our school have even been tested. Our kids use the sinks in their classrooms to wash and prepare fruits and vegetables, clean their classrooms, and engage in other Montessori-taught "life skills" like measuring. Our kids use water sources to cultivate our school garden and then harvest the food they grow to cook meals at school. We cannot responsibly use these water sources until we know they are safe for our children, and we are preparing to divert PTSO funds from other projects to hire an independent tester because we do not trust DGS to provide safe, lead-free water for our children. We need to know when DGS will test all of our water sources and prove to us they are safe.

Finally, this ineptitude and oversights are surely indicative of the broader problems facing our school community and building. If DCPS and DGS did not notify us of the significant lead problem at our school, what other problems are undiscovered and/or uncommunicated to us? Our school desperately needs a modernization, and the Council should amend the CIP to provide one for us.

In the meantime, would you like a drink from my son's little pirate water bottle? Probably not.
